## FINANCIAL POLICIES

Automatic tuition payments are withdrawn the 15<sup>th</sup> of each month depending upon the closest date to enrollment or otherwise stated by FAF. Your payments will begin on July 15<sup>th</sup> and end on June 15<sup>th</sup>. Full and half-year payments may still be made by check in the FAF Office.

- No account is to be more than 30 days overdue. **All accounts past 30 days must submit a written payment plan to the FAF School Board for approval.** You may be asked to withdraw your child if your financial obligations are not maintained according to any approved plan of payment.
- **No past due accounts (including those with an approved payment plan) are eligible to receive grade cards, academic records, or schedule teacher conferences.** Past due accounts are not eligible to re-enroll until the account is current.
- All automatic tuition withdrawals returned by the bank will be assessed any NSF fees to applicable family accounts.
- **Miscellaneous fees (enrollment, labs, late pick-up, tutoring, aftercare, etc.) will be billed separately unless otherwise arranged at enrollment.** These fees must be paid before the school year begins and may be paid with enrollment fees.
- Questions concerning your account should be directed to Mr. Foreman or in writing to the FAF School Board.

## YEAR END BALANCES

If you have re-enrolled and still have a balance due on June 30<sup>th</sup>, your child's name may be removed from the upcoming school year's class list and that spot will be opened for another student.

## REGISTRATION (non-refundable, returning students)

If received <b>by</b> <u>March 31<sup>st</sup></u> (Fees <b>and</b> forms on first come first served basis)	\$50 per student, \$200 max per family (does not include any new student amount)
If received <b>after</b> <u>March 31<sup>st</sup></u> <b>before</b> <u>June 1<sup>st</sup></u>	\$75 per student, \$300 max per family (does not include any new student amount)

## NEW STUDENTS (non-refundable, K5-6<sup>th</sup> grade siblings of re-enrolling students)

If received <b>by</b> <u>May 31<sup>st</sup></u>	\$100 per student, \$300 max per family
If received <b>after</b> <u>May 31<sup>st</sup></u>	\$125 per student, \$375 max per family (does not include returning students)
